INTRODUCTION

Coral Production Corp. performed site closure activities at the USA Brew and Peterson 1 & 2 leases in Morgan County Colorado in compliance with Rule 909, Site Investigation, Remediation, and Closure. A Form 27 was submitted and assigned Remediation Project number 14238. This document summarizes the final phase of the closure activities which includes the disposal of excavated soil and initialization of reclamation activities.

FIELD ACTIVITIES

Coral Production Corp. contracted with TJS Yards to excavate and stockpile hydrocarbon impacted soil as detailed in our Sampling Results Report dated October 8, 2014. Analytical results demonstrated that excavation activities reduced the hydrocarbon levels below Table 910-1 standards, therefore the contractor proceeded with loading trucks provided by Waste Management of Colorado Energy Services. The soil was transported to Waste Management's Buffalo Ridge Landfill in Keensburg, CO from November 14-17, 2019. Twenty-five truckloads were removed from the site (a manifest summary is attached).

REMEDIATION ACTIVITIES

After approval of the Form 27 Supplemental Form by the COGCC, T J S Yards is initiating the final grading and seeding operations, weather permitting. Seeding will be covered by crimped straw. Those areas include the tank batteries, wellheads and access roads as identified in the Soil Testing Results report attached to the Supplemental Form 27. Photocopies of the proposed seed mixtures are attached.

CONCLUSIONS

The remediation activities performed to date include the excavation and hauling of petroleum contaminated soil and final grading of the site. A Form 27 requesting No Further Action status will be submitted once seeding has been implemented. Copies of disposal manifests and haul tickets will be kept on file for at least five years as required by Rule 907.b(2).
