

**Response to December 2, 2019 Inspection

COGCC conducted an inspection of the Schaefer 13-14F location (Location ID 327830) on December 2, 2019 (Document 696501182). During that inspection, COGCC made the following observations:

Trash Comment: Broken concrete next to tank berm. Comply with Rule 603.f.

Tanks and Berms Comment: Secondary containment is inadequate to contain largest single tank plus sufficient freeboard. Repair or install berms or other secondary containment devices per Rule 605.a.(4)

Response: Noble removed debris from the site (603.f.). The berm surrounding the crude oil tank and the produced water pit was repaired to provide adequate secondary containment [605.a.(4)]. The repaired secondary containment provides adequate storage of the largest single tank and sufficient freeboard to contain precipitation.
