COMMENTS:

Bradenhead test as reported on Form 17 Doc ID 402281095 shows 20 psi pressure and continuous oil flow at surface. Surface casing is set at 212 ft. The plan for repairing the well is to first pressure test the production casing. If it does not test, a retrievable packer on tubing will be used to isolate the leak. The leak will be squeezed with cement, drilled out, and casing will be pressure tested again. Bradenhead will also be retested after a successful squeeze. If the production casing does pass the initial pressure test, the production casing will be perforated just below the surface casing shoe and a cement squeeze performed. Casing will be drilled out, pressure tested and bradenhead tested for pressure & flow. Additional squeeze work will be performed across aquifers as directed by COGCC.
