#### COMMENTS:

Form 4 is being filed for the Spady Brothers #1 for continued TA status purposes even though the well has only been shut in. The well was shut in 11/2008 when gas sales for the field gathering system was lost. A successful MIT was performed on 8/2/2017. Renegade is hopeful that gas sales can be reestablished with the LDC and therefore believes the wellbore has value. The well is closed to atmosphere by surface valves with bull plugs. Enviromental risk of the well is very low.
