INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On 12/6/19, five discreet confirmation soil samples were collected (4 wall and 1 base) from the produced water tank excavation. Initial visual and olfactory observations and photoionization detector (PID) readings did not indicate the presence of impacted soil within the excavation. The base and wall sample from the west wall were analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH) gasoline range organics (GRO), and TPH-diesel range organics (DRO). In addition, the base sample was analyzed for pH, Electrical Conductivity (EC), and Sodium Absorption Ratio (SAR). Concentrations of BTEX, naphthalene, TPH-GRO, and TPH-DRO were either not detected at or above laboratory reporting limits or were reported below their respective Table 910-1 concentration levels, with the exception of TPH-DRO concentrations in the west wall sample, reported at 644 milligrams per kilogram (mg/kg), which is above the Table 910-1 concentration level 500 mg/kg. The pH in the base sample was reported at 9.62, which is above the Table 910-1 concentration range of 6-9. SAR concentrations in the base sample were reported at 30.64, which is also above its Table 910-1 concentration range of less than 12. EC was reported at 0.180 millimhos per centimeter (mmhos/cm), which is within its Table 910-1 concentration range of <4 mmhos/cm. The base sample was collected outside of the root bearing zone at 5.0 feet below ground surface (bgs). See the attached laboratory report, analytical summary Table 1, and Figure 3.

Over-excavation activities are planned to commence on December 16, 2019 to address the TPH-DRO concentrations reported above Table 910-1 concentration levels in the confirmation soil sample collected from the west wall of the initial excavation (SWWest-5). One confirmation soil sample will be collected from the west wall and analyzed for BTEX, TPH-GRO, and TPH-DRO.

Proposed Groundwater Sampling

If groundwater is encountered in the base of the excavation, grab groundwater samples will be collected and analyzed for BTEX. The number and location of the samples shall be appropriate to confirm whether groundwater has been impacted. Chemically Oxygenated Granular Activated Carbon (COGAC™) may be applied and thoroughly mixed in prior to backfill with clean overburden and imported material.

Approximately 4.1 cubic yards of impacted soil was transported offsite under Great Western manifest to Waste Management's Buffalo Ridge Landfill (a licensed disposal facility) located in Keenesburg, Colorado. Copies of the waste manifests are attached.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). On December 16, 2019, Great Western completed over-excavation activities at the west wall of the initial excavation. The over-excavation measured approximately 18 feet by 15 feet by 6 feet deep. One confirmation soil re-sample (West SW-5) was collected from the west wall of the over-excavation and analyzed for BTEX, TPH-GRO, and TPH-DRO. Concentrations of BTEX, TPH-GRO, and TPH-DRO were not reported at or above laboratory reporting limits, serving as confirmation that impacted soils along the west wall of the initial excavation have been successfully removed.
