Mark and Ann,

Thank you for meeting with us on Wednesday, January 8<sup>th</sup>, 2020, to discuss the Mead 9-E Pad. From this meeting and from the email we received from you, it is our understanding that the original permits were filed by Extraction Oil & Gas at the end of 2018 (actually re-files). Bayswater and Extraction have been working on a transfer of ownership for this location. Prior to SB181, direction was given to Bayswater by both Weld County and the COGCC to have Extraction continue through the permitting process and after the location was permitted to then do the transfer of ownership. The transfer of ownership has recently been approved at the COGCC, however, with the implementation of SB181, local disposition now has to be given for locations within Weld County prior to COGCC Form 2s and 2As being approved. It has been requested that Weld County allow the Form 2s and 2A to be approved prior to completing the 1041WOGLA process. Bayswater acknowledges that they still need to have an approved 1041WOGLA prior to any activity commencing for this location.

John and Doug,

Please accept this email as acknowledgement that for this location only, due to certain circumstances which are unique to this location, Weld County is agreeable to the Form 2s and 2A being approved and issued by the COGCC prior to Bayswater completing the 1041 WOGLA process. Bayswater has in fact begun the process with Weld County – the record number assigned to this location is 1041WOGLA20-0001.
