**COMMENTS:**

Annual Form 4 is being filed for the Spady Brothers #1 for continued TA status purposes even though the well has only been shut in. The well was shut in 11/2008 when gas sales for the field gathering system was lost. A successful MIT was performed on 8/2/2017. Renegade is hopeful that gas sales can be reestablished with the LDC and therefore believes the wellbore has value. It is being considered that the well be placed back on and the very small amount of gas would be flared. The Spady Brothers #1 is closed to atmosphere by surface valves with bull plugs. Pumping equipment is utilized on the well. No downhole isolation is in place as the retrievable bridge plug used for the MIT test was removed afterwards. Environmental risk of the well is very low.
