 On 1-9-2020, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to noise. The complainant Erin Polen 3711 Mount Powell Dr Broomfield CO stated the issues were occurring outside of complainants home.
 On 1-10-2020, I attempted to make contact with the complainant who indicated that on 1-9-2020 experienced a low hum and banging noise throughout the entire night.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not hear any unusual noise in or around location.
 After reviewing data submitted by third party, location appears to be within COGCC rules. Third party sound data will be attached to complaint inspection document.
 At time of inspection, I spoke with fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place. This is Liberty Oilfield Services Tier 4 Quiet fleet.
