While there I saw no evidence of Drip staining noted at Well head or Subsidence at well head exposing cellar from previous inspection document # 692401083. The lease road is snow covered and could not identify if Subsidence is occurring at culvert area of access road from previous inspection so any Corrective Actions from previous Inspections that have not been addressed are still applicable.

During this inspection the following possible compliance issues were observed:

- Weeds around well heads/ location.
