**General Comment:**

On January 6th, 2020, Reclamation Specialist Trujillo conducted a Final reclamation and stormwater inspection at D&D Resources Inc's Emerald #267 Location in Rio Blanco County, Colorado.

The following alleged compliance issues were observed during this inspection:

Unable to find evidence that corrective actions have been addressed; No form 6(s) or associated plugging/abandonment documents have been submitted for well. At the time of inspection Location was covered in snow and preventing the Reclamation Specialist from conducting an accurate assessment of the reclamation. A follow-up inspection will be needed in a future growing season to determine compliance.

Required documents have not been submitted per corrective action. At the time of inspection Location was covered in snow and prevented the Reclamation Specialist from conducting an accurate assessment of the reclamation. A follow-up inspection will be needed in a future growing season to determine compliance.

Location will remain out of compliance until corrective actions have been addressed.
