**General Comment:**

On January 6th, 2020, Reclamation Specialist Trujillo conducted a Final reclamation and stormwater inspection at Diamond Back Drilling & Supply Inc.'s Emerald 222 Location in Rio Blanco County, Colorado.

1004.a: It was observed that Location does not appear to have been recontoured or regraded. Cut slopes remain evident
