 On 1-12-2020, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Odor/noise. The complainant Donna Yannett 4776 Raven Run Broomfield CO stated the issues were occurring outside of complainants home. On 1-15-2020, I attempted to make contact with the complainant who indicated that on 1-10-2020 she experienced Constant humming Banging overnight into the next day. Also on and off odors. She stated smelling a sewage smell and paint thinner. Complainant's home is approximately 3300ft SW from the Livingston location. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I could not associate these odors with any oil and gas activities. At time of inspection, I did not observe any unusual noise in or around location. After reviewing Third party sound data it appears location complies with COGCC rules. Third party data will be attached to complaint inspection document. At time of inspection, I spoke with fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place. Weather conditions: Clear See inspection document #693502068 per my inspection. No violation of COGCC rules were observed at the time of the inspection.
