TEP Rocky Mountain LLC ("TEP") respectfully reports that one temporary 300 bbl condensate tank, in a 24' x 24' lined steel containment, was installed on the north end of the Clough 103 location (ID #335633) as depicted on the attached site diagram. This tank will store condensate from the RWF 12-9 pad (Loc ID #335636), DOE RM 2-8 pad (Loc ID #335743), DOE 1-W-9 pad (Loc ID #335637) and RWF 324-9 pad (Loc ID #311663). TEP is planning to remove this temporary tank following the installation of one (1) new two-inch (2") FlexPipe condensate pipeline from the Clough 103 to the Clough 104 pad and installation of new tanks within the existing tank battery on the Clough 104 pad (COGCC Form 4 Doc# 402226625).
