## COMMENTS:

TEP Rocky Mountain LLC (TEP) is requesting approval to add production equipment to the Clough 104 Pad (COGCC Loc ID# 322416) to support the storage of condensate from the ten (10) proposed wells on the Federal RWF 12-9 Pad (COGCC Loc ID# 335636, Amended Form 2A Doc #402165012). These tanks will also support storage of condensate from the existing wells on the RWF 12-9 pad (Loc ID #335636), DOE RM 2-8 pad (Loc ID #335743), DOE 1-W-9 pad (Loc ID #335637) and RWF 324-9 pad (Loc ID #311663).

TEP will upgrade the existing tank battery by installing two (2) five-hundred-barrel (500bbl) condensate tanks within the existing tank containment structure. The five-hundred-barrel (500bbl) gun barrel will be relocated and placed within the larger containment structure and the existing twenty foot (20') by forty foot (40') containment structure will be removed. Three (3) emissions control devices will be installed seventy-five-feet (75') northwest of the existing tank battery. Two (2) existing condensate pipelines, approximately 4,160 feet in length, would be replaced with two-inch (2") FlexPipe from the drainage crossing located in Lot 3 of Section 16, Township 6 South, Range 94 West, 6th P.M. to the existing tank battery on the Clough 104 pad.
