Pursuant to Rule 210.b., within 60 days after the completion of a well or the installation of a battery, Operator shall install a permanent sign at the wellhead. This sign shall provide, among other required information, a phone number at which the Operator can be reached at all times and a phone number for local emergency services (911 where available).  
On 11/09/2018 COGCC Staff performed an inspection of Noble Energy Inc's Arnold E 21-9 lease and noted improper emergency contact signage in doc#691200770.  
On 12/17/2018 COGCC Staff performed a followup inspection of Noble Energy Inc's Arnold E 21-9 lease and noted improper emergency contact signage in doc#691200975.  
Operator failed to provide a phone number at which the Operator can be reached at all times and a phone number for local emergency services, violating Rule 210.b.
