COMMENTS:

Citation Oil & Gas Corp. requests approval to retain this well in a temporarily abandoned status. The well was originally abandoned due to low oil production. We are currently evaluating our options to add nitrogen injection to the Frontera Unit. We would like to retain TA status to test gas injectivity for a future enhanced oil recovery project and will make a decision on or before 6/2020. There is a CIBP at 5138' with 2 sxs cement on top isolating the Morrow perfs at 5188-5208. The well is closed off to the atmosphere by valves and plugs in the tubing and casing.
