Foundation proposes to collect 6 soil samples by hand auger for the pit closure investigation - 1 base sample and 4 sidewall samples. The final sample collection point will be at the location of N03@6', a sample collected during the 2015/2016 soil investigation after oil was noted on the pit. Other samples taken during the investigation delineated impacts (see attached sample map and analytical result table). The excavation has remained open since that time. Foundation would like to close the pit and the open remediation event.

Foundation is still investigating the root cause of the oil in the pit. Once identified and corrected surface soil samples will be collected from the base and the four walls of the pit and analyzed for analysis of Gasoline Range Organics (GRO), Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), Diesel Range Organics (DRO), pH, electrical conductivity, and Sodium Adsorption Ratio. Soils that exhibit concentrations above COGCC Table 910-1 standards will be removed and disposed of or treated onsite.

## REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Updated - 5/16/18 - Since pit closure soil samples have not been collected yet, Foundation will require additional data in order to develop the remediation plan. However, should soil in the pit base, sidewalls, or location of impacts from 2 years ago exceed the Table 910-1 standard, soil will be removed from the pit and transported to the Waste Management Ault CO facility. An open remediation number from 2015, #9288, indicates that impacted soil was present at sample location N03@6'. A sample will be collected at this location, below the weathered, exposed soil as the original sample was collected 2/1/16 and the excavation has been open since that time. Additional samples collected 2/1/16 showed the extent of impacted soil, leaving the one location to resolve for closure. Samples will be run for GBTEX and TPH, plus pH, EC, and SAR on locations less than 3' in depth.  
\* Update 1/9/20 - This remediation project number was completed in late 2019 under #14234, which closed the entire former pit.

Updated 5/16/18 - Once soil samples collected from all sample locations show concentrations less than the Table 910-1 standard, the berms will be pushed into the base of the pit. Additional topsoil will be brought in and compacted to bring the pit area to surface and prepared for seeding with dryland pasture seed mix. If soil amendments are necessary to increase the chance of success at seeding, Foundation will add amendments based on inorganic soil results.  
\*Update 1/9/20 - All equipment has been removed from the former Sooner battery. The former pit has been backfilled. The location will be recontoured and reseeded in spring 2020 as soon as weather conditions allow.
