As reported in the previous Form 27 (COGCC Document ID 402276335), soil sample 20191220-C16OU(NBOTTOM) @ 21' exhibited EC, SAR, and TPH exceedances. Impacted soil represented by this sample will continue to be removed via excavation to a maximum depth of 30 feet below pad surface. If excavation is to continue beyond this maximum depth, then discussions will be held internally to decide on a feasible and safe way to continue remediation of impacted soil. Impacted soil will continue to be transported to Greenleaf Environmental Services for disposal.
