However, Operator has not provided any details or documentation regarding what reclamation work has been conducted (e.g. Imported topsoil if needed, soil ammendments if needed, seed mixture provided by surface owner or local soil conservation service/NRCS, seeding rates and methods, stabilization controls implemented to stabilize seeded soil, etc...) on the additional disturbed areas offsite. Corrective action will remain applicable and a followup inspection will be conducted to determine compliance with the corrective actions and COGCC 1000 series rules.

Corrective actions remain applicable and a followup inspection will be conducted to determine compliance with COGCC Rules.
