Revegetation will help provide long term stabilization. Temporary erosion control measures such as natural fiber erosion control blankets, need to be installed until perennial vegetation is established.

Operator Comment: Location was assessed for stormwater and multiple stormwater BMP's were installed as well and clean out of existing controls. Rock rundowns installed and existing BMP's cleaned out. Seeding was performed on cut slope and covered with a coconut mat to stabilize and attempt to vegetate. Diversion ditches were cleaned out and re-established. Silt deposits were removed.
