Cole,

Thanks, please include this email with each of the Form 6(S) that are filed on these wells. It is also understood that the following COA will apply to all of these wells.,

"Assure that wellbore is static, no pressure or flow, prior to pumping combined shoe/surface plug. Tag required if cement has not circulated to surface or fails to remain at surface when pumping stops."

This COA is meant to imply that there will be a tag after the first stage as well as at the surface is the cement decides to fall.

Steve,

As discussed on the phone this morning Crestone Peak would like to change all of our P&As going forward to bring the surface casing shoe cement plug all the way to surface. This change is due to recent successes on the Grant Brothers 42-26 and 31-26 as well as the Ray Nelson 8-8-32 and 34-32 surface casing shoe plugs. Going forward the shoe plug will start at the depth stated on the Form 6 and will extend all the way to surface. This plug will be pumped in two stages to ensure there are no gaps in the plug. Below is a list of the wells that have an approved or pending Form 6 that we will apply this philosophy to.
