In accordance with COGCC Rule 905.b, confirmation samples will be collected below the buried or partially buried produced water vessel during decommissioning or relocation activities.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Soil encountered below the produced water vessel will be field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID). In addition, visual and olfactory observations of the soil will be documented. A confirmation soil sample will be collected below the vessel and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260B, TPH – diesel range organics (DRO) by EPA Method 8015, pH by EPA Method 9045D, and electrical conductivity (EC) by EPA Method 120.1. If groundwater is encountered below the vessel, a soil sample will be collected from the unsaturated interval and submitted for laboratory analysis of the above-stated compounds.

Approximately 140 cubic yards of impacted material were excavated and transported to the North Weld Waste Management Facility for disposal under PDC waste manifests.

## REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). A historic release was discovered below the former produced water tank during facility decommissioning activities. Excavation activities were conducted and approximately 140 cubic yards of impacted material were removed and transported to the North Weld Waste Management Facility for disposal. Eight soil samples (SS01 – SS08) were collected from the sidewalls and base of the excavation extent at 6 feet and 12 feet below ground surface (bgs). Samples were submitted to Summit Scientific Laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260B, and TPH – diesel range organics (DRO) by EPA Method 8015. In addition, soil sample SS01 was submitted for laboratory analysis of pH by EPA Method 9045D and electrical conductivity (EC) by EPA Method 120.1. Analytical results indicated that constituent concentrations were below COGCC Table 910-1 standards in all soil sample locations.
