 On 1-14-2020, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Helene Snyder 4617 Hope Circle Broomfield CO stated the issues were occurring outside of complainants home.  
 On 1-15-2020, I attempted to make contact with the complainant who indicated that on 1-14-2020 she experienced a low frequency noise. Complainant's home is approx... 2800ft North West of the Livingston well pad.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise in or around location. Third party sound data has been submitted and after further review it appears at time of complaint, location complies with COGCC rules. Sound study data will be attached to compliant inspection document.  
 At time of inspection, I spoke with fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place.
