Apex Companies, LLC (Apex) is presenting this letter to Kerr-McGee Oil & Gas Onshore LP (Kerr-McGee) documenting the results of a vegetation assessment that demonstrates successful completion of interim reclamation efforts, per COGCC Rule 1003, on the above-referenced location. Attached is a topographic location map and a site map with additional location information.

Site visits and the completed vegetation assessment confirmed that the reduced drilling and construction footprint has been recontoured and returned to the landowner for cropland and agricultural use. Based on this result, interim reclamation, as defined by COGCC Rule 1003.e (1), has been achieved. Photographs required by Rule 1003.e (3) are attached, along with the site map that illustrates the photo points.

On July 15, 2019, the site was visited and four photographs documenting crop establishment on all sides of the location were taken, along with one photograph illustrating planted crops.

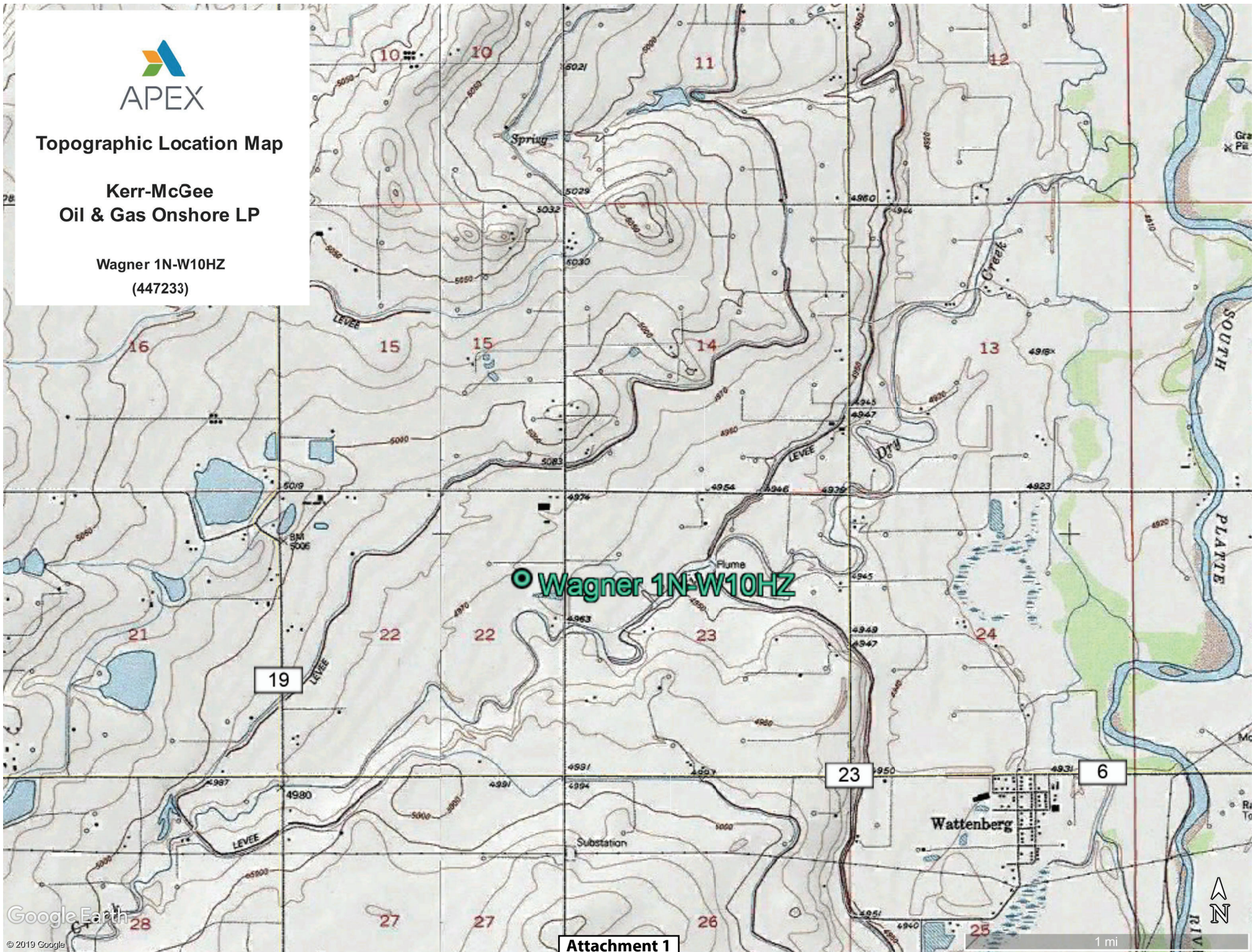

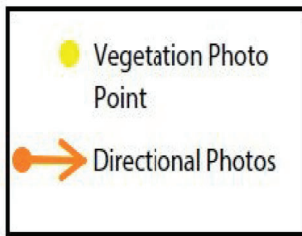




Vegetation Survey Site Map
