This inspection is solely for the dried and abandoned Fairfield Kitti A #5 well.

Form 6(N) #400921938 states the Kitti A #5 was intended to be the original wellbore for the location; rig was skidded and a new hole drilled; API 103-12278 was created for the original wellbore drilled before the well was skidded and became known as API 103-11010=01.

Only one active well on Location; passing of final reclamation well release solely for the DA well on the active location.
