FIR No. 680102062 documented two (2) risers remaining on the Location and that vegetation of the Location does not meet reclamation requirements. Inspection required operator to remove equipment and conduct reclamation.

It was observed in this inspection that equipment appears to have been removed. Surface of the Location covered in snow preventing reclamation specialist to conduct an accurate assessment of the reclamation, and determination if additional reclamation activities have been conducted. A followup inspection will be conducted during a future growing season to determine compliance with 1004 Rules.
