Comment Location is infested with musk thistles and Russian knapweed. As it is partially snow covered, jointed goatgrass identified during 2018 inspection could be present. Weeds are not controlled.

Corrective Action Control weeds. This is the second corrective action for weeds at this location. Weed infested areas will need revegetation after weeds are controlled. Corrective action is back-dated to document duration of non-compliance.
