Soil encountered below the produced water vessels will be field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID). In addition, visual and olfactory observations of the soil will be documented. Confirmation soil samples will be collected below the vessels and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260B, TPH – diesel range organics (DRO) by EPA Method 8015, pH by EPA Method 9045D, and electrical conductivity (EC) by EPA Method 120.1. If groundwater is encountered below the vessels, soil samples will be collected from the unsaturated interval and submitted for laboratory analysis of the above-stated compounds.
