The pit will have grab soil samples collected from the 4 cardinal directions 2.5' below the ground surface on the side walls, as well as from the pit bottom. The sidewall samples will be field screened in a 1-gallon clear plastic ziplock bag with a PID and the highest reading of the 4 will be sent to the lab for analysis, along with the pit bottom grab sample. Soil samples will be sent to Origins Laboratory in Denver for DRO/GRO/BTEX (sidewall and pit bottom) and EC/pH/SAR (sidewall only) analyses.
