On 1/28/2020, Reclamation Specialist Trujillo conducted a final reclamation and stormwater inspection at CHEVRON USA INC # 16700's U P 66-16 Location in Rio Blanco County, Colorado.

It was observed in this inspection that pipe debris remains to the west of the well. Location appears to have been recontoured/regraded. Shrub vegetation has established throughout well site. Unable to observe surface vegetation due to snow cover.
