The following concerns were addressed:

- Noise - Mrs. Davenport's first concern was noise. She said there was constant compressor noise and invited us out to listen. The noise was coming from the Boulter Farms location. Repairs were made to a compressor to minimize the noise. Also, PDC redesigned the Grays Federal site to place our production facility further north, as far away from the Davenport home as possible.

The following concerns were addressed:

- Truck traffic – Explained the operations, reasoning of the well positioning and that PDC redesigned the location in order to move the facilities as far north and away from his home as possible. He understood and was appreciative of the redesign.
- Noise – Mr. Davenport's main concern was the noise from a different facility (Boulter Farms). Due to the proximity of the production facility, we offered to mitigate noise with trees. Mr. Davenport and his wife are going to submit bids for trees from a nursery of their choosing for PDC to purchase. The Davenport's would be responsible for installation and maintenance of the trees.
