#### COMMENTS:

Noble has performed three blowdowns on the Five Rivers K08-23. The first blowdown, performed on 12/6/2019, started at 124 psi and collected 2.2 mcf of gas and 3 gallons of fluid. The second blowdown, performed 12/27/2019, started at 114 psi and collected 2.7 mcf of gas and 53 gallons of fluid. The third blowdown, performed 1/20/2020, started at 117 psi and collected 4.1 mcf gas and 0.5 gallons of fluid. A Form 17 was completed on 1/24/2020, beginning at 82 psi (402303009). A gas sample was not collected prior to blowdown, but production gas sample was collected during the Form 17 and will be submitted. Water to surface is present in the bradenhead and there is not enough gas to collect a bradenhead gas sample.

We are electing to P&A rather than continue with the monitor and blow down program. This well will be P&A'd before 8/1/2020.
