KPK has removed the existing shed housing the equipment responsible for the accumulation of oil waste on the ground. With the shed removed, out of service equipment was removed. Abandoned flowlines will be taken out of service in compliance with Rule 1103. During removal of out of service equipment, an unknown active flowline was disconnected releasing between 5 and 10 bbl of commingled fluids on the surface.
