INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Based on the results of the 6/13/19 hand auger assessment, Western conducted additional source removal excavation and on 7/29/2019 and LT Environmental, Inc. collected confirmation soil samples. The extent of excavation was approximately 30-feet by 30-feet to 20-feet below ground surface (bgs). Five soil samples were collected: one from each sidewall at 18-ft bgs and one from the floor at 20-ft bgs of the excavated pit for lab analysis of BTEX, TPH-GRO/DRO/ORO. All samples exceeded the COGCC Table 910-1 standard for TPH and the east wall sample (SE-3@18) exceeded the COGCC Table 910-1 standard for benzene. Based on these results, Western conducted additional excavation on November 4, 2019. The final extent of the excavation was approximately 31-feet by 31-feet to 21-feet below grade. Results of the hand auger assessment and July 2019 excavation were presented in previous reports.

On November 13, 2019, Western collected five confirmation soil samples from the excavation. One soil sample was collected from each side wall at 19 feet bgs and one soil sample was collected from the floor at 21 feet bgs. The samples were submitted for laboratory analysis of BTEX and TPH-GRO/DRO/ORO. All results were below the laboratory reporting limit and compliant with COGCC Table 910-1 standards. The soil sample location map, laboratory analytical report, and soil results summary table are attached.
