 Field Inspector Actions:
 On 01-31-2020, I Adam Burns area field inspector was assigned a complaint (low frequency, vibration) received by COGCC staff in reference to Noise. The complainant contacted my supervisor, Adam Kraich via phone call to report the complaint. The complainant was directed to file a complaint with the commission on the COGCC website.
 On 01/31/2020, I along with supervisor Adam Kraich set a sound meter at 562 Cherry Lane, in Windsor CO. 40.48687, -104.87346. The sound audit began 1/31/2020 and ended 2/3/2020. Only nighttime (21:00 to 08:00) hours were used in the study. Additionally, the only usable data in the study was 1/31/2020 to 2/1/2020, as wind speed is beyond 5mph for the remaining dates.
 The resulting data from the study, is an LEQ 2 of 72.1 DB, which suggest noncompliance of rule 802.d.
