PLUGGING RECORD

INSTRUCTIONS

Within thirty (30) days after the plugging of any well, the owner or operator thereof shall file this form in duplicate for wells on Patented or Federal lands, and in triplicate for wells on State lands, give a detailed account of the manner in which the abandonment or plugging work was carried out, including the nature and quantities of materials used in plugging and the location and extent (by depths) of the plugs of different materials; records of the amount, size and location (by depths) of casings and junk left in the well; and a detailed statement of the volume and weight of mud fluid used.

DETAILS OF WORK

- 1-28-59 PBSD 2280' Moving in casing pulling machine, rig up, clean cellar.
- 1-29-59 Clean out cellar to top of 10 3/4" casing.
- 1-30-59 Installing casing jacks, working 8 5/8" casing, finding freepoint with McCullough, cut off at 2000'.
- 1-31-59 Pulling 8 5/8" casing, filled hole to 2005'. Put 7 sx reg. cement in place with bailer. Top of cement at 1990'.
- 2- 1-59 PBSD 1990'. Pulling 8 5/8" casing.
- 2- 2-59 Finished pulling 8 5/8" casing, preparing to pull 10 3/4".
- 2-11-59 Pulled 310' 10 3/4" casing.
- 2-12-59 Filled hole with mud - 1990' to 315'. Bridged hole at 315'. Cemented with 10 sx reg. cement - 315' to 295'.
- 2-13-59 Filled hole with mud 295' - 15'. Put 10 sx cement plug in top of 12 1/2" casing - 27' - 15'. Rig released 5 PM 2-13-59.
- 2-14-59 Cellar filled with dirt and well marker installed.
