COMMENTS:

As a result of the Form 17 bradenhead test (Document ID: c7621cb0-5305-435e-a74f-75094cce01c6), Crestone Peak has added this well to our bradenhead blowdown schedule. The well will be blown down weekly to 0 psi through either our portable combustor trailer or blowdown trailer, then shut in. During the blow down and build up cycles, the pressure and rate will be recorded in such a way as to characterize the well performance for comparison over time. Commencing with the submission of this sundry, Crestone will perform up to six months of blow down and build up cycles. At the conclusion of the six months, Crestone will conduct a new bradenhead test and submit a Form 17 within ten days of the test. Crestone will submit a Form 4 Sundry that summarizes current well condition within 60 days of the bradenhead test.
