COGIS is showing the Oil and Gas location to be the SESW, however our surveys show the location to be in the SWSE.

The Windows/Twinning exception location waiver is included as an attachment.

The State Seventy Holes T-P-6HNB [API: 05-123-37405], operated by Bonanza Creek, is the nearest well in the same formation, the distance was measured in 2D. This well is currently PR.

The nearest wellbore belonging to another operator was measured to the planned Middlepark #18-4-1L [API #: 05-123-47443], operated by Confluence DJ LLC (10518). The distance was measured in 2D. This well's status is XX.

No wells owned by other operators are Producing, Temporarily Abandoned, or Shut-In within 150' of this well's productive lateral, therefore stimulation setback consent is not needed.

Per correspondence with COGCC staff because the original APD submittals were withdrawn and did not expire, a new PSU letter to WI owners is not required. The wellbore has no changes from the original submittal, therefore the PSU is the same.

1	Drilling/Completion Operations	Prior to drilling operations, Operator will perform an anti-collision scan of existing offset wells that have the potential of being within close proximity of the proposed well. This anti-collision scan will include definitive MWD or gyro surveys of the offset wells with included error of uncertainty per survey instrument, and compared against the proposed well path with its respective error of uncertainty. If current surveys do not exist for the offset wells, Operator may have gyro surveys conducted to verify bottom hole location. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision, or harm to people or the environment.
2	Drilling/Completion Operations	Operator will comply with the "COGCC Policy for Bradenhead Monitoring during Hydraulic Fracturing Treatments in the Greater Wattenberg Area", dated May 29, 2012.
3	Drilling/Completion Operations	Alternative Logging Program: One of the first wells drilled on the pad will be logged with an open-hole resistivity log and gamma-ray, from the kick-off point into the surface casing. All wells on the pad will have a cement bond log (CBL) with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.
