COMMENTS:

Please be advised that the Lost Creek #5 well was intermittently shut in on 3/1/2017. The since the well has now been shut in for an extended period of time O'Brien Energy is requesting TA status approval for the following reasons; The Lost Creek #5 well is a natural gas well located in Weld County that produce from a low pressure reservoir. Although there are sufficient reserves still in place the well had to be shut in as it could not compete with the excessive pipeline pressure that have continuously climbed over the last few years. This is a direct result of the spike in shale activity in this area that has surrounded our well. Not only have the local pipeline pressures skyrocketed but also the price of natural gas has plummeted. With that said, we initially intended to shut the well in for a short period of time as we anticipated a drop in the local pipeline pressures and firming up of gas prices. Unfortunately the line pressures have not subsided and pricing still remains at historic lows which is why we are requesting to place the Lost Creek #5 well into TA status.
