#### COMMENTS:

Please be advised that the Lost Creek #4 well was shut in on 03/01/2017. This well was shut in for the following reasons: Extended excessive pipeline pressures have directly impacted the wells ability to produce sufficient volumes of natural gas into our purchaser's pipeline. The increased pipeline pressures are a result of all the new Niobrara Shale gas that is now being produced into it. The Lost Creek #4 well is capable of producing approximately 10 mcf per day when line pressures are marginally high. When line pressures are low we estimate the well is capable of producing approximately 20 to 25 mcf per day. An MIT test is scheduled to be conducted on 3/2/2020.
