Operator Comment: KPK maintains that the barbed wire fencing currently located around the pumpjack satisfies that requirements of COGCC Rule 605.c.(3). As written, Rule 605.c.(3) requires that: "All pumps, pits, and producing facilities shall be adequately fenced to prevent access by unauthorized persons when the producing site or equipment is easily accessible to the public and poses a physical or health hazard." Here, the barbed wire fence effectively prevents

access by unauthorized person. Unauthorized persons would have to intentionally cut and remove the fence to gain access to the production equipment. Moreover, it is inherently dangerous and extremely difficult for anyone to try to climb over this type of fencing. Finally, in the event of a trespass by unauthorized persons, all equipment contains proper OSHA guarding.
