Nature of complaint: Complainant indicated electrical poles and power lines used for the well location have been left abandoned; power line begins at the NENE of Section 20 crossing property to the south, ending at location of former oil well.

COGCC staff findings:
Staff does not believe the Operator has left electrical poles and power lines at the well location. It appears the Operator has removed the one electrical pole at the well location- see Photo 2. Also, the electrical poles and power lines indicated by the complainant do not terminate at the well location- See Photos 1-2, and 4-5.

Note: Operator submitted a Form 4 Final Reclamation Complete Notice (Doc.# 401794346) indicating utility poles and overhead wire have been removed.

Comment:

This is a Final Reclamation Inspection for PA Well API#075-07464. Well was plugged and abandoned 10/27/2015. At the time of this inspection, areas (tank battery, pit area, portions of the well location access road and well location) do not meet Rule 1004 standards. Germination of winter wheat was not observed within portions of the described areas. Refer to the attached inspection photos for more detail.

Note: Operator submitted a Form 4 Final Reclamation Complete Notice on 11/05/2018 (Doc.# 401794346) with attached photos. The attached photos taken March 2018 further illustrate areas did not meet Rule 1004 standards at that time, as crop growth was not reflective of reference areas.

Corrective Action:

Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.

The corrective date is not intended to be the date for which the Operator shall complete the corrective actions but rather the corrective date is the date the location was observed out of compliance.
