Impacted soil was excavated at the site in January 2016 and transported to a licensed landfill for disposal. Soil samples were collected from the excavation sidewalls and floor and submitted for laboratory analysis of BTEX, TPH-GRO, TPH-DRO, and Naphthalene.

Four temporary monitoring wells have been installed on site, as illustrated in the figures associated with the Excavation and Assessment report. Borehole soil samples and initial groundwater samples from these wells indicated that concentrations of analytes were below COGCC Table 910-1 standards. Groundwater was not encountered during the January 2016 excavation and no additional groundwater samples were collected.
