3. TIH with CIBP. Set BP at 6881'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6580'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with tubing to 1920'. RU cementing company. Mix and pump 35 sxs 14.8#/gal Type III cement down tubing (Pierre coverage from 1900'-1400'). TOC at 1400'.
6. Pickup tubing to 744'. Mix and pump 65 sxs 14.8#/gal Type III cement down tubing. Cement circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
