## INITIAL ACTION SUMMARY

KPK is requesting to remove the 35 bbl produced water storage vessel, which meets the definition of a partially buried vessel, from the CHAMPLIN 117 AMOCO I Tank Battery. The wells associated to the tank battery are being P&A'd and the facility is planned to be removed. The partially buried storage vessel will be permanently closed per Rule 905.b.
