COMMENTS:

TEP Rocky Mountain LLC (TEP) respectfully requests to vent the bradenhead for 1 year as needed. TEP's calculations for pressure at the surface shoe set depth have determined that this well's shut in pressure, combined with the hydrostatic pressure of the fluid and gas column in the production casing annulus, have exceeded a 0.683 psi/ft gradient at the shoe. In order to alleviate this pressure, TEP requests permission to vent the bradenhead if the calculated pressures exceed the 0.683 psi/ft gradient in order to avoid potentially breaking down the surface shoe. This well will not be continuously vented. Roots meter was installed for 24 hrs and BH flowed 0 cf of gas recorded.
