Comment

This location does not comply with Rule 1003.b. Interim areas consist mostly of Russian thistle with little to no desirable vegetation which is not reflective of reference area vegetation. There is a thick (~3-5") layer of Russian thistle thatch (dead vegetative material) within the dense areas likely negatively affecting successful germination of desirable species.

Corrective Action

Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards.
