COGCC staff will have to perform a follow up final reclamation inspection for a spill area and ensure equipment and final reclamation has been completed at the tank battery location.

Access road appears to be in use for a temporarily abandoned well to the northwest.

Operator shall perform final reclamation at the tank battery once all the equipment has been removed.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
