## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

During plugging and abandonment activities at the Shutt Federal 16-18A facility, historical petroleum hydrocarbon impacts to the subsurface were encountered beneath the partially buried produced water vessel (PWV). The volume of the release is unknown. Based on the volume of impacted soil excavated, the release was reported to the COGCC on January 14, 2020. The general site layout is depicted on the Excavation Site Map provided as Figure 1.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Between January 10 and February 10, 2020, following removal of the PWV, soil samples were collected from the sidewalls and base of the excavation. Twenty soil samples were collected from the excavation for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. The base soil samples were also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results indicated that BTEX, TPH, pH, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels at the extent of the excavation. The soil sample analytical results are summarized in Table 1, and the laboratory analytical reports are attached. The soil sample locations are depicted on Figure 1.

Approximately 1,080 cubic yards of impacted soil were excavated and transported to the Kerr-McGee Land Treatment Facility in Weld County, Colorado, for recycling. The general site layout and excavation footprint are depicted on the Excavation Site Map provided as Figure 1.

Laboratory results indicate that soil sample concentrations and levels are in compliance with COGCC allowable levels at the extent of the excavation. Groundwater was not encountered in the PWV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
