#### COMMENTS:

Noble has performed two blowdowns on the Monfort Gilcrest K08-08. The first blowdown, performed on 12/11/2019, started at 50 psi and collected 0 mcf of gas and 44.9 gallons of fluid. The second blowdown, performed 1/16/2020, started at 40 psi and collected 0 mcf gas and 9 gallons of fluid. A Form 17 was completed on 1/24/2020, beginning at 43 psi (attached). A gas sample was not collected prior to blowdown, but production gas and bradenhead gas & water samples were collected during the Form 17 (doc # 402303038) and will be submitted.

We are electing to P&A rather than continue with the monitor and blow down program. This well will be P&A'd before 8/1/2020.
